

Minutes Regular Meeting Bellbrook-Sugarcreek Park District September 28, 2023

CALL TO ORDER

The Regular Meeting of the Board of Park Commissioners of the Bellbrook-Sugarcreek Park District, also known as the Bellbrook-Sugarcreek Park District, was held at the Park Headquarters. The meeting was called to order at 7:00 A.M. with the following in attendance: Commissioners Haller, Tischer, Johnson, Mr. Stewart, Executive Director and Sarah Mantia, Business Manager. APPROVAL OF MINUTES

\$19,112.19 was moved to Land Acquisition Fund from checking on 8/22 for local government funds received.

NEW BUSINESS

Contract Approval - Brown Paving & Construction

Mr. Johnson moved, Mr. Haller seconded, and the Commission approved a motion for Jeff Stewart, Executive Director to enter into a contract with Brown Paving & Construction for an amount not to exceed \$30,000.00 to apply an asphalt overlay to the walking path at Ron Kehl Park.

STAFF REPORTS

- Program staff participated in Community Clean-up Day on 9/9. Over 100 people assisted in clean-up activities at Morris Reserve, Kehl Park, Magee Park and Sweet Arrow Reserve.
- Date for Halloween in the Park was moved to 10/28 to avoid a Chamber of Commerce sponsored program scheduled for 10/14.
- New programing for Seniors has been scheduled for the coming months. All sessions have filled with waitlists.
- Grant funded walkway has been completed at Petrikis. Play apparatus to be installed once concrete has cured.
- Additional athletic fields have been overseeded at both Washington Mill and Sackett Wright Parks.
- City of Bellbrook requested to install additional an electric panel at Bellbrock Park. All upgrades to be borne by the City.

- Historical Society highlighted Morris Reserve at their last meeting.
- The Park District and the local Optimist Club will be partnering to have the large Spruce tree at Bellbrock Park decorated for the upcoming holiday season.
- Ms. Mantia provided an extensive overview of the proposed site design for Magee Park and potential upgrades that will be contingent upon grant funding.
