

Minutes Regular Meeting Bellbrook-Sugarcreek Park District July 22, 2021

CALL TO ORDER

The Regular Meeting of the Board of Park Commissioners of the Bellbrook-Sugarcreek Park District, also known as the Bellbrook-Sugarcreek Park District, was held at the Park Headquarters. The meeting was called to order at 7:00 A.M. with the following in attendance: Commissioners Ackerman, Tischer and Mr. Stewart, Executive Director. Notice of this meeting was sent to the Xenia Daily Gazette on January 12, 2021.

APPROVAL OF MINUTES

Mr. Ackerman moved, Mr. Tischer seconded, and the minutes of the June 24, 2021 scheduled Regular Meeting were approved as delivered to all members in advance.

VISITORS

Mr. Rob Reigelsperger and Ms. Lisa Burke representing the Bellbrook Soccer Association expressed gratitude to the Park District for working with their organization and specifically Mr. Johnson for taking the time to address their concerns and the efforts put forth in working with the Communities Recognized Athletic Organizations. Mr. Tischer thanked both for taking the time to come to the meeting and appreciated the acknowledgment.

Mr. Stork representing the Bellbrook Sugarcreek High School Women's Soccer Program had comments about the current Athletic Field Use Policy, specifically the requirement of a 51% minimum of the participants by Bellbrook/Sugarcreek Township residents. Mr. Stork reinforced that his concern is stemming from the impact of the policy on the BSHS Women's Soccer Program as opposed to representing the interest any one independent Club soccer organization. Mr. Stork explained that his challenge is that his team at BSHS competes at a Division 1 level and out of nearly 200 schools that BSHS is one of the smallest within the division and fielding a competitive team can be challenging with the small population of girls he is working with. Mr. Stork shared that one of his current teams comprises of players from various Soccer Clubs including Ohio Galaxies, CUSA, Club Ohio and Warrior's and the level of skills that the girl's acquire from participating in organizations with this level of training is critical to the success of the High School program. Mr. Stork said he can appreciate a policy that provides an allocation process that prioritizes the actual needs for the Recognized Organizations first, but surplus field space should be allowed to be allocated without regard to residency status provided they pay a non-resident fee to the Park District. Mr. Stewart thanked Mr. Stork for his comments and stated that his comments would be taken into consideration when the policy is reviewed for any potential modifications.

The Recreational Trails Program Story Book Trail Application

OLD BUSINESS

Athletics - Mr. Stewart

- Tentative field requests have been received from the athletic organizations for the upcoming season.
- Two softball fields at Sackett Wright Park have been converted from a grass infield playing surface to dirt as requested by the local baseball organizations.
- Large baseball diamond at Sackett Wright Park has been renovated due to flood damage.
- Request received from Bellbrook Soccer Association to decrease mowing height at Washington Mill Park.

Staff Reports - Mr. Stewart

- Collaboration with Greene County Public Library to conduct several large events at Magee Park and Washington Mill Park.
- Partnership with Greene County Council on Aging continues to expand by offering several new programs.
- Brookview demolition is 80% complete
- Shelters at Sackett Wright Park have been painted and one has been re-shingled.
- Gazebo at Petrikis Park has been painted.
- Several parks experienced significant damage for storms earlier this month including tree damage, stream crossing wash-out and damage to several electrical components at the Park Headquarters.
